ORDINANCE 12-15

ORDINANCE OF THE MUNICIPAL COUNCIL OF THE BOROUGH OF SOUTH TOMS RIVER, COUNTY OF OCEAN, NEW JERSEY ADOPTING THE 'REDEVELOPMENT PLAN FOR 19 DOUBLE TROUBLE ROAD, BLOCK 19, LOT 1' PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 et seq.

WHEREAS, the Borough of South Toms River (the "Borough") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq., as amended from time to time (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment and/or rehabilitation; and

WHEREAS, the Municipal Council (the "Municipal Council") designated the entirety of the property in the Borough as an area in need of rehabilitation (the "Rehabilitation Area") by Resolution 2015-121 adopted on April 27, 2015 after hearing from the Borough Tax Assessor that within the Rehabilitation Area more than half of the housing stock is at least fifty (50) years old, in accordance with the requirements of N.J.S.A. 40:12A-14, and upon the recommendation of the Borough Planning Board (the "Planning Board"); and

WHEREAS, by commission of the Municipal Council, David G. Roberts, AICP, PP of Maser Consulting, P.A. ("Planning Consultant") has prepared a redevelopment plan for property in the Borough located at 19 Double Trouble Road (also known as Block 19, Lot 1) entitled "Redevelopment Plan for 19 Double Trouble Road, Block 19, Lot 1" ("Redevelopment Plan," attached hereto as *Exhibit A*); and

WHEREAS, on November 9, 2015, the Municipal Council introduced this ordinance in accordance with *N.J.S.A.* 40A:12A-7 which simultaneously referred the Redevelopment Plan to the Planning Board for its review and recommendation; and

WHEREAS, on November 16, 2015, the Planning Board reviewed the Redevelopment Plan and adopted a resolution recommending its adoption; and

WHEREAS, upon review of the Planning Board's recommendation of the Redevelopment Plan, the Municipal Council has determined to adopt the Redevelopment Plan to ensure the success of redevelopment of 19 Double Trouble Road within the Rehabilitation Area in conformity with the Borough's redevelopment objectives.

NOW THEREFORE BE IT ORDAINED, by the Municipal Council of the Borough of South Toms River, in the County of Ocean, New Jersey, as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.

- 2. The Redevelopment Plan for 19 Double Trouble Road, attached hereto as *Exhibit A*, is hereby adopted pursuant to the terms of *N.J.S.A.* 40A:12A-7.
- 3. The zoning district map included in the zoning ordinance of the Borough is hereby amended to reference and delineate the property described and governed by the Redevelopment Plan. All of the provisions of the Redevelopment Plan shall supersede the applicable development regulations of the Borough's municipal code, as and where indicated.
- 4. A copy of this Ordinance and the Redevelopment Plan shall be available for public inspection at the office of the Borough Clerk during regular business hours.
 - 5. This Ordinance shall take effect in accordance with all applicable laws.
