Notes - Tax Impact.

Please note that the tax impact as presented on UFB-1 Tax Impact-DLGS for the average assessed home in the Borough of South Toms River as calculated by the User Friendly Budget document is not correct. The Borough underwent a tax revaluation in 2015 effective 2016. The total assessed valuation decreased from \$271,633,084 for 2015 to \$220,503,621 for 2016. The average residential assessment decreased from \$205,779.37 for 2015 to \$164,792.38 for 2016.

While the 2015 amount for municipal taxes of \$2,240.94 is correct, the 2016 amount of \$2,942.64 is incorrect. The correct amount for the average home assessed at \$164,792.38 with a municipal tax rate of \$1.48 per \$100 of assessed valuation is 2,356.53, an increase of \$115.59 from 2015 to 2016, Not \$701.71.
