MINUTES OF REGULAR CAUCUS MEETING

The Meeting of the Borough Council of the Borough of South Toms River was brought to order by Mayor Oscar Cradle. Mayor Cradle started with a Moment of Silence and Flag Salute.

The Borough Administrator/Clerk informed the Governing Body that Roll Call reflects less than a quorum. The Borough proceeded with Students of the Month and mentioned that since there is not a quorum, there will only be discussion and no official action.

Will Jubert, 5 Dartmouth, asked if the Borough has a process for street sweeping.

The Borough Clerk confirmed the County provides sweeping through schedule C.

The Borough closed Public Comment with no other comments from the public.

The Borough Attorney authorized Executive Session for Contract Negotiations and Attorney-Client Privilege

Due to absence of a quorum, no official action was taken on any ordinances or resolution.

The Borough Clerk reminded all those serving on boards or committees that the Annual Financial Disclosure Statements are due by the end of April.

Mayor Cradle stated that the Borough will be looking into altering the Garbage and Recycling pickup based on votes from questions posed on PlanetCivic, and plan to take Governing Body action at the next Council meeting.

Councilman Ross stated that the Borough used to provide this and seems likely to be reimplemented.

Councilman Handshy reminded everyone that the shredding event will be Saturday May 12th from 9-11am at the Recreation Building.
