**ORDINANCE NO. 2023-10**

**BOROUGH OF SOUTH TOMS RIVER**

**AN ORDINANCE PROVIDING FUNDING FOR THE PURCHASE OF A  
COMPACT WHEEL LOADER FOR THE BOROUGH OF SOUTH TOMS  
RIVER AND APPROPRIATING \$70,000 FOR SUCH PURPOSE.**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH TOMS RIVER, IN THE COUNTY OF OCEAN AND STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. The Borough of South Toms River, in the County of Ocean, New Jersey, authorizes funds for the purchase of a Compact Wheel Loader for the Borough of South Toms River to be funded from the sources specified in Section 2 of the Ordinance.

Section 2. The amount of \$70,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the General Capital Fund Balance in the amount of \$70,000.

Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Borough of South Toms River may lawfully make as a general improvement.

Section 4. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.

**ORDINANCE NO. 2023- 11**

**AN ORDINANCE OF THE BOROUGH OF SOUTH  
TOMS RIVER, COUNTY OF OCEAN, STATE OF NEW  
JERSEY AMENDING AND SUPPLEMENTING  
VARIOUS PROVISIONS OF CHAPTER 3 OF THE  
BOROUGH CODE ENTITLED "POLICE  
REGULATIONS"**

**THEREFORE, BE IT ORDAINED** by the Mayor and Borough Council of  
the Borough of South Toms River, County of Ocean, State of New Jersey as follows:

**SECTION 1.** Chapter 3 of the Borough Code, entitled "Police Regulations"  
specifically Section 3-2 entitled "POSSESSION OR CONSUMPTION OF  
ALCOHOLIC BEVERAGES" is hereby renamed "CONSUMPTION OF  
ALCOHOLIC BEVERAGES AND/OR CANNABIS." and shall read as follows:

**§3-2.1. Consumption Of Alcoholic Beverages And/Or Cannabis in  
Public and Private Places**

- a. It shall be unlawful for any person to buy, consume or carry any open alcoholic beverage container in or on any public or quasi-public place, building, or roadway.
- b. At certain specifically designated recreation areas, the Mayor and Council may issue a special permit for the consumption of alcoholic beverages at a picnic or other activity sponsored by a nonprofit corporation or organization, provided that proper application has been made for same, and applicant is in compliance with all related requirements.
- c. It shall be unlawful consume any cannabis product in in or on any public or quasi-public place, building, or roadway.

**SECTION 2.** Chapter 3 of the Borough Code, entitled "Police Regulations"  
specifically Section 3-24 entitled "SMOKING PROHIBITION." is hereby amended and  
supplemented to read as follows:

**§3-24. SMOKING PROHIBITED.**

### **§3-24.1. Prohibition.**

Smoking is hereby prohibited in or on all property owned by the Borough.

### **§3-24.2. Definitions.**

#### **ELECTRONIC SMOKING DEVICE**

An electronic device that can be used to deliver nicotine or other substances to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, cigarillo, or pipe.

#### **PERSON**

Any individual.

#### **PUBLIC FACILITIES**

The public facilities covered under this section include the entire buildings and grounds of all municipally owned properties and public schools.

#### **SMOKING**

The burning of, inhaling from, exhaling the smoke from, or the possession of a lighted cigar, cigarette, pipe or any other matter or substance which contains tobacco, or any other matter that can be smoked or inhaled, or the inhaling or exhaling of smoke or vapor from an electronic smoking device.

### **§3-24.3. Smoking Areas.**

The Mayor and Council may, at their discretion, designate smoking areas outside of the public buildings covered by this article. Said areas shall bear signs specifically designating that they are smoking areas.

### **§3-24.4. Smoking Areas.**

"No Smoking" signs shall be clearly and conspicuously posted by the Borough of South Toms River at all public properties and shall reference the applicable Code provision herein. The color of such signs, when not of the international type, shall have letters that are distinct, contrasting to the background and easily read. Letters shall have a minimum height of three-quarters of an inch and should be posted in English and such other languages as the governing body shall decide.

### **§3-24.5. Enforcement.**

The provisions of this article shall be enforceable by a police officer or public works employee.

### **§3-24.6. Violations and Penalties.**

- a. Any person violating the provisions of this article shall be subject to a fine of not less than \$50 nor more than \$200 for each violation. A person

found guilty of a second or subsequent offense shall be subject to a fine of not less than \$50 nor more than \$500.

- b. Any person found guilty of defacing or removing "No Smoking" signs which are required by this article shall be subject to a fine not less than \$200 nor more than \$500, plus the costs of replacing the sign.

**SECTION 3.** If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect or invalidate the remainder of this Ordinance but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

**SECTION 4.** All Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed, but only to the extent of such inconsistencies.

**SECTION 5.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 6.** This ordinance shall take effect after second reading and publication as required by law.

PROCLAMATION

Proclaiming the month of September 2023 as Prostate Cancer Awareness Month.

**Whereas,** This year, approximately 288,300 men will be diagnosed with prostate cancer in the United States alone – one man every 2 minutes, and roughly 34,700 will die this year from the disease, about 3,500 more than 2020 – which is one man every 15 minutes; and

**Whereas,** In New Jersey, an estimated 9,460 new cases of prostate cancer will be diagnosed and an estimated 730 deaths will occur in 2023; and

**Whereas,** Men with relatives – father, brother, son – with a history of prostate cancer are twice as likely to develop the disease; and

**Whereas,** Prostate cancer is the most commonly diagnosed cancer in American Men and the third leading cause of cancer death behind lung and colon cancer; and

**Whereas,** 1 in 8 men are diagnosed with prostate cancer in their lifetime and 1 in 6 African American men will develop prostate cancer in their lifetime. Overall, African American men are 1.7 times more likely to be diagnosed with - and 2.1 times more likely to die from - prostate cancer than white men; and

**Whereas,** Veterans who were exposed to herbicides like Agent Orange are at increased risk for developing prostate cancer, and are more likely to have an aggressive form of the disease; and


**Whereas,** Education regarding prostate cancer and early detection strategies is critical to saving lives, preserving, and protecting our families. As well as the economic and social burden of prostate cancer is huge on families; and

**Whereas,** If caught early prostate cancer has a five-year survival rate of nearly 100%. However, for late stage prostate cancer the five-year survival rate is 31%; and  
**Whereas,** Many more men will be diagnosed in 2023 at a later stage because of delayed screenings and treatment due to Covid-19; and

**Whereas,** All men are at risk for prostate cancer and we encourage the citizens of the Borough of South Toms River to increase the importance of prostate awareness and screenings.

**NOW, THEREFORE, BE IT RESOLVED;** I, Mayor Oscar Cradle, do hereby proclaim the month of September 2023 to be PROSTATE CANCER AWARENESS MONTH in the Borough of South Toms River.

As requested, Van Cleef Engineering Associates (Van Cleef) is pleased to submit to you a cost proposal for preparation of the required Master Plan Re-Examination Report. This estimate includes both planning and legal work for the entire scope of this project. We would welcome the opportunity to provide additional information and answer any questions at the next Planning Board meeting if so desired by the Borough, including a brief rundown of the expected deliverable timeline.

Below is a breakdown of tasks and a brief description of the work that will be completed under each of those respective tasks. Based on the following scope of work, we propose the entire project can be completed for a lump sum fee of **\$15,500**. Van Cleef will complete the project within approximately six (6) months of the acceptance of this proposal.

#### Scope of Services

##### **Task 1 – Background Document Collection & Review**

1. Van Cleef will review the Borough current Master Plan along with the various other plans and reports that have been drafted since the last Master Plan (Redevelopment Plans, Zoning Ordinance Changes, Housing Element & Affordable Housing Plan, 2010 & 2020 Census Data, etc.) to determine what has been accomplished and what recommendations can be made to further implement the goals set forth in the Master Plan;
2. Review zoning to determine where recommended best and highest uses are proposed in the town;
3. Collect GIS data and organize data in preparation for map creation (if required).

##### **Task 2 – Mapping**

1. Make recommendations for revisions to the land use and zoning maps in accordance with the updates mentioned in the Re-Examination Report. Van Cleef will coordinate with the Borough to obtain map files for Van Cleef to use to perform updates accordingly. This task is contingent upon the Borough being able to provide the various map files as approved file types (AutoCad, GIS, PDF, etc.).
